RESOLTUION

20-152 Motion by Mrs. Domhoff, Second by Mr. Krispinsky to approve a RESOLUTION TO SUSPEND A PORTION OF BOARD POLICY 0131 DURING PERIOD OF EMERGENCY DUE TO COVID-19.

WHEREAS, on March 9, 2020 the Governor of the State of Ohio issued Executive Order 2020-01D ("Order") declaring a state of emergency for the entire State to protect the well-being of the citizens of Ohio from the dangerous effects of COVID-19, and such state of emergency exists until the present day and likely will continue to exist for the foreseeable future; and

WHEREAS, Governing Board Policy 0131 requires, in part, that "bylaws and policies...may be adopted, amended, and repealed at any meeting of the Board, provided the proposed adoption, amendment, or repeal shall have been proposed at a previous Board meeting";

WHEREAS, this Policy 0131 requirement has proven challenging during the period of time in which COVID-19 continues to impact the entire State of Ohio and likewise the Governing Board of the Trumbull County Educational Service Center in serious and immediate ways; the Governing Board must be able to act efficiently to respond to ESC and school district needs; and

WHEREAS, this Policy 0131 further provides in relevant part, these "bylaws and policies may be adopted or amended or a single meeting of the Board in an emergency. An emergency shall be defined for purposes of this rule as any situation or set of circumstances which the Board has reason to believe will close the schools or jeopardize the safety and welfare of the students or employees of the Center;" and

WHEREAS, as a result, the Governing Board seeks to suspend the requirement that bylaws and policies to be adopted, amended, and/or repealed must be proposed at a previous Board meeting — e.g., presentation at two Governing Board meetings — for the duration of the COVID-19 crisis.

NOW, THEREFORE, BE IT RESOLVED that the Governing Board of the Trumbull County Educational Service Center hereby temporarily suspends the portion of current Board Policy 0131 that reads "bylaws and policies...may be adopted, amended, and repealed at any meeting of the Board, provided the proposed adoption, amendment, or repeal shall have been proposed at a previous Board meeting" effective the date of this Resolution through the duration of the 2020-2021 school year.

BE IT FURTHER RESOLVED that, as a result, any policy adoptions and/or revisions may be made at the first Governing Board meeting in which the policy adoption and/or revision is introduced, in order to allow the Governing

Board to be able to act efficiently to respond to ESC and school district needs during the period of emergency.

BE IT FURTHER RESOLVED, the Governing Board hereby temporarily suspends, to the extent allowable by law, current Board policy and/or local rules or regulations, effective the date of this Resolution through the duration of the 2020-2021 school year, to the extent that said policies, rules or regulations conflict with this Resolution.

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal actions of this Governing Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Governing Board in compliance with all legal requirements, including H.B. 197 and Section 121.22 of the Ohio Revised Code.

8450.01 - PROTECTIVE FACIAL COVERINGS DURING PANDEMIC/EPIDEMIC EVENTS

During times of elevated communicable disease community spread (pandemic or epidemic), the Superintendent will issue periodic guidance through Governing Board plans/resolution(s) in alignment with public health officials and/or in accordance with government edicts and including any Pandemic Plan developed by the Educational Service Center's Pandemic Response Team under Policy 8420.

School settings can be a source of community spread. Wearing face masks/coverings is especially important during these times and can help mitigate the risk of exposure from person to person.

As such, during times of elevated communicable disease community spread, the Superintendent may activate this policy by notifying the school community, requiring all school staff, volunteers and visitors (including vendors) to wear appropriate face masks/coverings on school grounds unless it is unsafe to do so or where doing so would significantly interfere with the Centers educational or operational processes.

In addition, the Board may require that while at the physical location/building of Center students shall wear a face mask unless they are unable to do so for a health or developmental reason. Efforts will be made to reduce any social stigma for a student who, for medical or developmental reasons, cannot and should not wear a mask.
