APPROVING CONTRACT WITH DATACOM, INC. FOR BUILDING SECURITY ENHANCEMENT PROJECT

The Superintendent recommends that the Board approve a contract with DataCom, Inc. for its Building Security Enhancement Project (the "Project").

Background:

- 1. The Board has identified a need to upgrade its security technology infrastructure at its central office location. The Project consists of, but is not limited to, installation, configuration, and training for building security systems hardware. The work for the Project was procured through a competitive proposal process outside of the statutory bidding requirements for public school districts, under O.R.C. 3313.46, as the Project is for the safety and protection of school facilities.
- 2. The Board will use Federal grant money to fund the Project; accordingly, in compliance with 2 C.F.R 200.320(a)(2), a public request for proposals was issued and proposals from four qualified vendors were received.
- 3. DataCom submitted a proposal in the amount of \$136,707.59 (the "Contract Sum").
- 4. Based on the announced evaluation criteria, DataCom was determined by District administration to be the responsible vendor whose proposal is most advantageous to the District, after evaluating price and other factors.
- 5. The Superintendent recommends the Board authorize an agreement with DataCom in an amount not-to-exceed the Contract Sum.
- 6. The Superintendent also requests authority for the Superintendent and Treasurer to negotiate and execute change orders or contract revisions on behalf of the Board in a total amount not-to-exceed 10% of the Contract Sum. Change orders or contract revisions in excess of that aggregate amount will be brought to the Board for its approval.

The Board of Education resolves as follows:

- 1. The Board finds an adequate number of price quotations have been obtained from qualified sources in accordance with 2 C.F.R § 200.320(a)(2).
- 2. The Board authorizes the Superintendent and Treasurer to work with legal counsel to negotiate and execute a contract with DataCom in an amount not-to-exceed the Contract Sum, and to sign any other related documentation, consistent with the intent of this Resolution.

3. The Board grants authority for the Superintendent and Treasurer to negotiate and execute change orders or contract revisions on behalf of the Board in a total amount not-to-exceed 10% of the Contract Sum. Change orders or contract revisions in excess of that aggregate amount will be brought to the Board for its approval.
